

**Affadavit of Norman Scott Edwards**

1. **Norman Scott Edwards**, herein "**Edwards**", of Port Austin Township, Huron County, Michigan, USA, declare under penalty of perjury, on this 8<sup>th</sup> day of December, 2004:

1. On, December 8, 2004, I received the **Affidavit of Meeting Minutes and Disillusionment of PASCC** from the Yahoo website, at the URL:  
<http://groups.yahoo.com/group/SabbatarianEducationalEnvironment/files/Legal%20Docs/>
2. Said Affidavit was confirmed to me on December 8, 2004, to be the genuine declaration of **Terry Monte Williams, Paul Douglas Drieman and Phillip Daniel Frankford**, herein "**the Three**", by the Notary Public, Caroline Sourva, to which it was sworn.
3. Said Affidavit is integrated with this document as pages 2 and 3.
4. Edwards notes the following statements in said Affidavit which he believes to be mistakes by **the Three**, and therefore assumes the following corrections:
  - a. The word "Disillusionment" in said Affidavit's title means to be disenchanted, which may be true, but is not likely to be a legal fact worth noting. Edwards assumes "dissolution" was the intended word as confirmed by point 3 on page 1.
  - b. The reference to Marleen Edwards in the third bullet point of said Affidavit on page 1 is unnecessary as she never had any leadership or membership position in any of the entities mentioned in the first bullet point on page 1.
  - c. Edwards was not notified of the meeting of the PASCC leadership team on October 31, 2004, but accepts the decisions made there as a majority of the PASCC founding ministers were present.
  - d. In the Affidavit, positions of **the Three** are variously stated as "Leadership Team", "official leadership", "Director", "Executive Director" and "Trustee". The only founding documents of the PASCC entities are "Declarations of Establishment" for the Port Austin Sabbatarian Church Community and the Port Austin Sabbatarian Community Church dated April 5, 2004. These documents contain no leadership titles other than "member" and "scribe". No scribe was appointed. No governing documents or minutes were ever approved. No written leadership appointments were made. However, since **the Three** and Edwards were the only members of said PASCC entities, it is possible that the first four of the above "positions" may have been verbally adopted by the decision of three without Edwards knowledge. The term "Trustee" used in said Affidavit is in error as none of the PASCC entities described therein is a trust. Extensive additional governing documents would be required to form a trust, and Edwards and **the Three** agree that none ever existed for those organizations described in the first bullet of said Affidavit. The Assignment of Land Contract and Purchase Agreement recorded at Liber 1048, Page 223 and the corresponding deed recorded at Liber 1078, Page 110 in the Deed Records of Huron County refer to "Port Austin Sabbatarian Church Community, a Sacred Purpose Trust", which is in error as no such trust indenture by that name has ever existed. Said error was corrected to "Port Austin Sabbatarian Church Community Sacred Purpose Trust", along with "Parcel 3" description and other significant errors, in accordance with point 19 of the contract filed at Liber 1048, Page 233. Such correction was made by a new contract filed at Liber 1073, Page 62, and a new deed filed at Liber 1080, Page 418 in the Deed Records of Huron County, Michigan, USA.
5. The third paragraph on page 2 of said Affidavit is in error as it claims that **the Three** "sought every opportunity to reconcile with the Edwards" but to his knowledge, none of **the Three** have sent him any copies of Said affidavit, any written communication in any form, or any oral communication related to this matter from October 31, 2004 to this date. To the contrary, Edwards certified mail sent by Edwards to some of **the Three** was returned unclaimed. Edwards has received and read all of his mail in regards to the ministries mentioned in said Affidavit, and has been available at his dwelling, almost continuously, within 500 yards of the dwellings of **the Three** on and after October 31, 2004.

~ Affidavit of Meeting Minutes and Disillusionment of PASCC ~

*In this document, the following will be known:*

- **PASCC will mean to include** - Port Austin Sabbatarian Church Community, Port Austin Sabbatarian Community Church, PASCC Chronicles, Sabbatarian Education Environment [SEE], Sabbatarian Elder Adult Living [SEAL], and PASCC Chronicles.
- **PASCC Governing Documents will mean to include** - The Holy Bible [Mat 18:15-20, 1 Co 5:1-13] is our authority. No other documents are known by the PASCC Leadership Team nor have been certified by PASCC and filed with PASCC Scribe as Governing Documents.
- **Edwards will mean to include** - Mr. Norman Scott Edwards and his wife Marleen Edwards.

A meeting of the Leadership team of PASCC was convened on October 31, 2004 at 13:00 hours.

Present at that meeting were a quorum of the PASCC Leadership Team -

Mr. Terry Williams, original founding member, Trustee, and PASCC Director of SEAL  
Mr. Paul Drieman, original founding member, Trustee, and PASCC Executive Director  
Mr. Phillip Frankford, original founding member, Trustee, and PASCC Director of Industry

Witnessing these actions were

Mrs. Marcia Drieman, Mrs. Kristal Frankford [by telephone], Miss Mary Drieman

**Actions of the PASCC Trustees and Leadership Team -**

During the October 31, 2004 meeting, the PASCC Trustees and Leadership Team made and unanimously passed three (3) actions as the official leadership of these ministries, communities, affiliations, and/or associations.

- 1) We moved and unanimously passed that the Edwards are removed and expelled from all ministries, communities, and affiliations known by the acronym PASCC.
- 2) We moved and unanimously passed that the Edwards are not to represent themselves as or use the names of PASCC in any the ministries, communities, affiliations, or associations.
  - a. We decree and direct the Edwards to cease and desist from referring to themselves in any way as PASCC in any ministries, communities, affiliations, associations or businesses dealings.
  - b. We forbid them to write or publish as representing these same names.
  - c. We forbid them to solicit or collect funds or gifts in these same names.
- 3) We moved and unanimously passed that the ministry, community and all associations or affiliations known by acronym PASCC are to cease to exist.

We jointly decree that all activities and business being done in these names be halted immediately. We agree to promptly close all accounts and business representations being done in these names. These include utilities, phone services, communication services, and USPS services.

Furthermore, we jointly disavow any knowledge or affiliation with the Edwards and any of their prior ministries, which include but are not limited to "The Servant's News", "The Church Bible Teaching Ministry", or "The Shelter in the Word"

We disavow any financial dealings, covenants, or other affiliations that they may or may not have taken.


We also, acknowledge before Almighty God and man, that the Edwards stand alone in completing any and all of pledges, covenants, and commitments that they may have made with or without our knowledge or consent.

We have sought with a pure and whole heart to do the will of the Almighty God and to see that we follow the admonition of the Almighty as reflected in Micah 6:8. We have sought every opportunity to reconcile with the Edwards and we have fasted and prayed before undertaking these actions.

- 6 Edwards hereby accepts said Affidavit and its provisions, with the corrections noted above, specifically
- Edwards accepts his removal from all of the various PASCSC entities named in the first bullet point on page 1 of said Affidavit. Edwards, obviously, cannot be held responsible for actions in these names, when he was unaware of his removal or the cessation of these entities. Edwards, in good faith, will cause to cease any remaining actions under these names by January 31, 2005. This interim time will be used to notify vendors and others concerned of the changes. Should **the Three** find Edwards not in compliance with this point, they must notify Edwards in writing via first class mail, after which he will correct the issue within 15 days.
  - Edwards accepts that all entities named in the first bullet point on page 1 of said Affidavit will cease to exist.
  - Edwards will continue to receive any mail erroneously sent to PO Box 610, Port Austin, Michigan, until the current box rent expires. Edwards will not make any additional payments to keep the PO box open. Edwards will correctly forward, unopened, any mail addressed to any of **the Three**. Edwards will send a change of address to anyone sending any other significant mail to that PO Box. He will not use this PO Box for any new correspondence. After the box rent expires, no forwarding address will be given for that PO Box.
  - Edwards accepts that **the Three** have no further financial dealings with Edwards as stated in the first two paragraphs on page 2 of said Affidavit. Specifically this means that **the Three** have no contracts, covenants or agreements, written or spoken, in regard to past relationships, and that any prior claims to such are now null and void. Specifically, neither **the Three** nor Edwards are indebted to each other in any way.
  - Edwards acknowledges that Terry Monte Williams may not have been informed or understood that said Affidavit, which he signed, releases Edwards from any responsibility to him for the funds which he expended on behalf of the PASCSC ministries. Allowing that he may have been deceived by others of **the Three**, Edwards reserves the right to decide to compensate Terry Monte Williams for his substantial efforts, so long as such compensation is not part of any legal action or agreement in any way involves Phillip Daniel Frankford, Paul Douglas Drieman or any of their associates or agents.
  - None of this agreement may be construed in any way to declare the cessation of the Port Austin Sabbatarian Church Community Sacred Purpose Trust, which was not named in said Affidavit and of which **the Three** are not trustees. Specifically, the use of the acronym PASCSC in legal documents where it stood for the Port Austin Sabbatarian Church Community Sacred Purpose Trust is not included in said Affidavit or this document. Future documents and correspondence will use the acronym PASCSCSPT for the Port Austin Sabbatarian Church Community Sacred Purpose Trust.
